146. QUESTIONS AND PETITIONS FROM MEMBERS OF THE PUBLIC

Question Received from Member of the Public:

"My understanding is West Berkshire Council is planning to develop the Faraday Road Football Ground with a new pitch including an enhanced stadium and to bring key sites forward on the adjoining London Road Industrial Estate (LRIE) on a plot-by-plot basis. Currently there is no policy, master plan, or development plan document to provide a detailed regeneration strategy for the LRIE or the adjoining Football Ground. Please would the Council formerly write to West Berkshire Council requesting they commission a Supplementary Planning Document (SPD) that incorporates a place-making strategy for the LRIE and adjoining Football Ground? This is to identify any missing drainage infrastructure in the area that has been delaying the regeneration of both the LRIE and Football ground, and to provide a mechanism to bring forward any necessary missing infrastructure."

Chairperson Responded with the following Response:

"Yes, we as Newbury Town Council will forward your question to WBC."

Supplementary question was received from Member of the Public:

"Please would the Council formerly write to West Berkshire Council asking them why on the 23rd of May 2024 (Ref EX4494 2.1 a. Attached) it was necessary to cancel the Supplementary Planning Document (SPD), and the Hemingway Place making Strategy and Delivery Plan that was due to be adopted by the end of 2024 (Ref EX4219 6.11 Attached) Due to the fact that hundreds of thousands of pounds had already been spent on consultants to produce the work and the SPD could have been expanded to cover the Newbury Town Center Master Plan Programme instead?

Chairperson Responded with the Following response:

"As your question is not a question that Newbury Town Council can answer and should be directed at West Berkshire Council, we will add it to you previous question when we write to West Berkshire Council for a response."
