**(Section 33 of the Localism Act 2011)**

I, Councillor JOAN IRENE DAY, hereby apply to the Town Council's Proper Officer for the following standing dispensations:

**Dispensations applicable to all Members:**

1. A dispensation for the period up to the next full Council elections in 2027 permitting any Member to speak and vote on The Newbury Town Council budget and precept

**Dispensations for all members who are also elected members of West Berkshire Council ("Dual-Hatted") and any members whose partners might be Members of West Berkshire Council.**

A dispensation to speak and vote on any of the following:

1. Any matter relating to any land transactions between Newbury Town Council and West Berkshire Council
2. Any matters relating to any financial transactions or grants between Newbury Town Council and West Berkshire Council
3. Any planning application or Local Plan matter where the promoter, applicant or landowner is West Berkshire Council
4. Any matter (from a Newbury Town Council perspective) on which the "dual-hatted" Member may be called upon to re-discuss in their capacity as a Member of a District Council Committee (e.g. Planning and Licensing Committees)

and that any breach of the Code of Conduct can be referred to West Berkshire Council 's Monitoring Officer for action.

c. I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest in accordance with section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of section 31(4) of the Localism Act 2011, or taking any steps in contravention of section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a member for a period not exceeding 5 years.
