In this present climate when we are being requested to walk and cycle, safety must be paramount in all our minds. Turnpike road between Fir Tree Lane and the Henwick roundabout, albeit a speed restricted area, does attract vehicles that might not be expecting to see children crossing between the Tiger's Nursery on the north side of the road to the specific footpath on the south side. The crossing of that road by minors and their parents or guardians is a fraught experience. Therefore, can this Planning and Highways committee of Newbury Town Council request West Berkshire Council to carry out a survey with the objective of installing a zebra crossing at some suitable point where the majority of pedestrian's cross.

# 72. Newbury Community Football Ground

Proposed: Councillor Jeff Beck

Seconded: Councillor Nigel Foot

**Resolved:** that the Committee writes as follows to West Berkshire Council: In June 2020 at Full Council meeting Newbury Town Council adopted the following changes to its Strategy:

# Lobby WBC to:

a) Provide a suitable football facility for Newbury's Men's, Ladies and Youth teams to play football at an equivalent or better standard than the old ground provided. This should be within the Newbury settlement area, with good walking and cycling access to the town centre, good public transport links and adequate parking. Inability to provision a suitable alternative site should result in the ground on Faraday Road being returned to its former standard or being redeveloped to an even better standard, with 3/4G pitches providing higher availability for matches and training.

Our Planning and Highways Committee last evening commented that since closure of the football ground in 2018, the buildings have been allowed to fall into dilapidation, the pitch has been neglected, the stand has been mostly removed and the security barrier around the pitch has also been removed. All of this has taken place without planning permission, and while we understand that such permission may not be required for some of the buildings at the football ground, it would be required should WBC demolish the pub at the football ground (An application for full planning permission is required to demolish pubs or other drinking establishments)

We also note that the recent SSL consultation found that the three options for alternative grounds on WBC owned land were not viable.

Therefore in line with our Strategy, we would request WBC to desist from any further demolition of the remaining facilities at the ground and take immediate steps to reopen the ground as an Asset of Community Value for the men's, ladies and youth football community in Newbury.

At the Planning & Highways committee of 3rd August 2020, the committee received a presentation from the Newbury Football Community Group with proposals demonstrating that the ground could be reopened in phases. The initial phase would see the ground opened for the community as a Step 7 facility with the lowest cost. Enhancements to return the ground back to a step 6 and then step 5 facility could be phased over a couple of years. This proposal was received well by the Committee and we would therefore recommend this approach to WBC to reopen this green space to the community of Newbury.
